FAIRMONT SUBDIVISIONS IMPROVEMENT ASSOCIATION 2024/2025 ELECTION BALLOT FOR BOARD OF DIRECTORS

The FSIA Board consists of Directors who serve on the Board for two (2) years. This ballot reflects 5 incumbents who have indicated their willingness to serve for another two-year term if elected by the Association's homeowners. This ballot is open to any write-ins you may wish to nominate and vote for, as long as the **nominee has indicated to you their willingness to serve** on the Board. You must also enter the house number and street name for the nominee. The person nominated must be a resident homeowner in good standing. The seven candidates with the most number of votes will be elected to the Board.

Instructions for voting: Only one (1) ballot per property by homeowners in good standing will be accepted. You may write in additional names on the lines provided. <u>Indicate your choice of no more than seven (7) candidates for placing "X" in the space before their preprinted or written in name.</u> You must provide your name and Fairmont property address for your ballot and seal with tape.

Ballots must be <u>received</u> on or before Friday, December 8, 2023. Late ballots will not be counted. Fax and telephone votes will not be accepted. You may mail your ballot to FSIA, P.O. Box 1052, Pacifica, CA 94044.
