City Council updates for Fairmont Homeowner Association. Grant funding for the Manor Drive Overcrossing Project (Item 6)

- The council authorized the city manager to apply for nearly \$4.95 million in grant funding for the Manor Drive Overcrossing Project. The project will widen the overcrossing at Highway 1, add new traffic lights, and even study the feasibility of a new on-ramp. The goal is simple: make traveling through Pacifica safer, smoother, and less congested—not just for drivers, but for cyclists and pedestrians too.
- With nearly \$4.95 million in grant funding, the city will work to widen the Manor Drive overcrossing and improve Highway 1 access—safer roads, less congestion, and better flow for everyone.

72 hours parking plus 1,000 feet (0.3 km) move (Item 7)

• Council just tightened up our 72-hour parking rule to make street parking more available for residents, businesses, and visitors. Now, if a car has been parked for three days, it must move at least 1,000 feet (0.3 Km) (around two-tenths of a mile) and stay away from that same spot for at least 24 hours. The parking ordinance discourages long-term vehicle storage on public streets, freeing up much-needed parking space in neighborhoods and busy commercial areas.

Short Summary

• Cars can no longer sit idle for days; they must move every 72 hours, 1,000 feet (0.3 km) from their previous location. Our updated ordinance makes spaces turn over faster, helping residents, businesses, and visitors find parking more easily.

Climate Action Item 8

• Pacifica took a big step forward in climate leadership. The City Council unanimously adopted the Climate Action and Resilience Plan (CARP) and officially formed the new Climate Action and Resilience Committee (CARC). The CARC group will guide the city in reducing greenhouse gas emissions, pursuing sustainability projects, and building resilience against climate impacts. They'll create an annual work plan, track progress, and connect with regional partners.
